The Terms and Conditions defines and outlines the expectations for both Ultimate Air Ride (hereafter referred to as UAR) and the purchaser of Ultimate Air Ride Products (hereafter referred to as Buyer or customer). By signing this agreement and through the purchase of an Ultimate Air Ride Suspension you are agreeing to the following terms and conditions. The terms and conditions are subject to change at any point with written consent by both Ultimate Air Ride and the buyer. Pricing on this quote is valid for 30 days.

Qualified Mechanic:

By signing this document you acknowledge the complexity of an Ultimate Air Ride suspension and commit that a qualified mechanic will be conducting the installation of the suspension. Ultimate Air Ride is not responsible for any installation errors or issues on/with the truck that come as a result of mismanaged installation. A qualified mechanic is defined as someone with advanced knowledge and understanding of the automotive industry, suspensions, and truck functions.

Wavier of Liability

By signing this document you are acknowledging that you are using Ultimate Air Ride to modify the original specifications of your truck. You understand that by installing any Ultimate Air Ride parts you are altering the truck and changing the way the truck rides, handles, and operates as a whole. By signing this document you are waving all liability of Ultimate Air Ride for any and all accidents, injuries or anything related to the later, that may occur during the operation of your truck with Ultimate Air Ride parts.

Custom Built Suspension:

By signing and dating this document the buyer is acknowledging that this is a custom built suspension to meet the specifications of the buyer's truck. With this understanding, UAR will begin to build and put together the suspension for the customer upon receiving this signed document. UAR is then subject to take a reasonable amount of time to assemble the suspension before shipping to the customer.

Return Policy:

Ultimate Air Ride offers a 30 day no questions asked return policy of the entire suspension with a 20% restocking fee. The buyer must contact Ultimate Air Ride within 30 days of the effective date of this invoice, informing UAR of the return. The buyer is then responsible for shipping all parts back to UAR and any costs associated with getting the entire suspension and all supporting parts back to UAR. Any missing parts will be will be charged to the buyer by UAR. Once UAR has received the returned parts and had a reasonable time to confirm all parts are returned, UAR will refund the buyer for the amount owed, less the cost of any missing parts and a 20% restocking fee.

Payment:

The buyer is expected to pay the full amount owed on the invoice before parts will be shipped. By filling in your credit card information on the provided line and signing/ dating this document you are agreeing to the total amount provided. By checking the box labeled "Cash Wire" you are agreeing to contact your bank and have the funds directly wired to the UAR bank account using the provided account and routing numbers. Additionally, you are acknowledging that the cost of shipping is To Be Determined (TBD) based on the address provided and the total weight of the parts being shipped. Once UAR has the kit ready to be shipped the shipping cost will be calculated and charged to the credit card provided or UAR will contact the buyer to wire the additional funds. Ultimate Air Ride will contact the buyer and confirm the amount of shipping with them before charging the card and shipping out the parts. By signing this document, the customer authorizes Ultimate Air Ride to charge the credit card given for the shipping charges which will be calculated at the time of shipment.

Shipping:

By filling in the section labeled "Shipping Address" with the address that you wish Ultimate Air Ride to ship this suspension to you are agreeing to the delivery of parts to this address. Ultimate Air Ride is not responsible for shipping errors as a result of the address being incorrect when filled out by the customer. UAR will send the customer confirmation of the product being shipped out with the tracking number for their records. Once parts have been shipped UAR is not responsible for any missing or damaged parts.

Warranty:

Ultimate Air Ride offers a lifetime warranty on any of our suspension parts under reasonable usage of the parts. UAR will not warranty any parts that have been altered, cut, or welded once it has left our manufacturing facility. UAR will not warranty any parts that have been used for anything other than their intended use. If the customer requires a warranty for any of our parts, they must send UAR an email to support@ultimateairride.com with a description of what happened to the part as well as a supporting picture of the faulty or broken part.

Buyer Personal Information:

Ultimate Air Ride agrees to never share the personal information of the customer in any way. Including but not limited to: email address, phone number, address, credit card information, or buyer name. UAR commits to take high precaution when handling all personal information with extra care to the customer's credit card information.
